## **Details of business transacted by the Depository and Depository Participant (DP)**

A Depository is an organization which holds securities of investors in electronic form. Depositories provide services to various market participants - Exchanges, Clearing Corporations, Depository Participants (DPs), Issuers and Investors in both primary as well as secondary markets. ## **Description of services provided by the Depository Participants (DP) to investors**

### **(1) Basic Services**

6	Registering pledge request	15 days
7	Closure of demat account	30 days
8	Settlement Instruction	Depositories to accept physical DIS for pay-in of securities upto 4 p.m and DIS in electronic form upto 6 p.m on T+1 day

**(2) Depository Participants provide special services like pledge, hypothecation, and internet based services etc. in addition to their core services and these include**

1	Value Added Services	Depository Participants also provide value added services such as a. <u>Basic Services Demat Account (BSDA)</u> b. <u>Transposition cum dematerialization</u> c. <u>Linkages with Clearing System</u> d. <u>Distribution of cash and non-cash corporate benefits (Bonus, Rights, IPOs etc.), stock lending.</u>
2	Transaction/Holding statement	Transaction/Holding statement is issued 10 days from the end of the month (if there were transactions in the previous month) or Yearly (if no transactions) .
3	Digitalization of services provided by the Depository Participants	Depository Participants offer below technology solutions and e-facilities to their demat account holders through DPs: a. <u>E-account opening</u> b. <u>Online instructions for execution</u> c. <u>e-DIS / Demat Gateway</u> d. <u>Transaction/Holding statement</u> e. <u>Miscellaneous services</u>

#### 4. Details of Grievance Redressal Mechanism

##### The Process of investor grievance redressal

1.	Investor Complaint/ Grievances	<p>Investor can lodge complaint/ grievance against the Depository/DP in the following ways:</p> <p>a. Offline mode [details of link to the form to be provided by DPs]</p> <p>The complaints/ grievances lodged directly with the Depository shall be resolved within 30 days.</p>
2.	Investor Grievance Redressal Committee of Depository	<p>If no amicable resolution is arrived, then the Investor has the option to refer the complaint/ grievance to the Grievance Redressal Committee (GRC) of the Depository. Upon receipt of reference, the GRC will endeavor to resolve the complaint/ grievance by hearing the parties and examining the necessary information and documents.</p>
3.	Arbitration proceedings	<p>The Investor may also avail the arbitration mechanism set out in the Byelaws and Business Rules/Operating Instructions of the Depository in relation to any grievance, or dispute relating to depository services. The arbitration reference shall be concluded by way of issue of an arbitral award within 4 months from the date of appointment of arbitrator(s).</p>

## 5. Guidance pertaining to special circumstances related to market activities: Termination of the Depository Participant

Sl No.	Type of special circumstances	Timelines for the Activity/ Service
1.	<ul style="list-style-type: none"> <li>Depositories to terminate the participation in case a participant no longer meets the eligibility criteria and/or any other grounds as mentioned in the bye laws like suspension of trading member by the Stock Exchanges.</li> <li>Participant surrenders the participation by its own wish.</li> </ul>	Client will have a right to transfer all its securities to any other Participant of its choice without any charges for the transfer within 30 days from the date of intimation by way of letter/email.

### Grievance Redressed Mechanism

**Level 1** – Approach the Depository Participants at the designated Investor Grievance e-mail ID: [grievances@msefsl.com](mailto:grievances@msefsl.com) of the Depository Participants. The Depository Participants will strive to redress the grievance immediately, but not later than 30 days of the receipt of the grievance.

**Level 2** – Approach the Depository using the grievance mechanism mentioned at the website of the respective Depository. Complaints Resolution Process at Depository explained graphically:

**Level 3** – Investor can lodge complaint/ grievance against the Depository/DP in the following ways:
